ROCHESTER GENESEE REGIONAL TRANSPORTATION AUTHORITY LICENSE AGREEMENT AND TERMS OF USE

Rochester Genesee Regional Transportation Authority ("RGRTA") generates and owns certain transit data (the "Data") that it is willing to make available on the terms and conditions set forth in this License Agreement and Terms of Use, as the same may be updated or modified by RGRTA from time to time without notice and in RGRTA's sole discretion (this "Agreement"). To access and use the Data, you must agree to be bound by this Agreement. If you do not agree to be bound by the terms of this Agreement, you may not download or use any Data. You confirm that you have read, understand and agree to the entire Agreement. Each time you download Data you ratify and confirm this Agreement, as modified through the date of that download.

1. RGRTA hereby grants you ("Licensee") a non-exclusive, limited and revocable right to use, reproduce, and distribute the Data subject to the terms and conditions set forth in this Agreement.

2. Licensee will not display or otherwise use any trademarks, service marks, logos, symbols, maps or other copyright materials of RGRTA or any of its subsidiaries, including without limitation Regional Transit Service, Inc., Lift Line, Inc., Batavia Bus Service, Inc., Livingston Area Transportation Service, Inc., Wayne Area Transportation Service, Inc., Wyoming Transit Service, Inc., Orleans Transit Service, Inc. and Seneca Transit Service, Inc. or any confusingly similar variants without express written permission in advance from RGRTA. Each page of any Licensee work using or displaying Data must contain the following disclaimer in conspicuous bond faced type:

Transit data provided by Rochester Genesee Regional Transportation Authority under license. RGRTA and its subsidiaries make no warranties with respect to the transit data, whether as to accuracy or otherwise. RGRTA has not endorsed this product. [Licensee's name here] is solely responsible for this product, and RGRTA and its subsidiaries have no liability with respect to it. RGRTA and its subsidiaries will not be liable for any damages, including indirect, special, incidental, consequential or punitive damages relating to or arising out of the use of the transit data.

3. LICENSEE AGREES THAT THE DATA IS PROVIDED "AS IS", "AS AVAILABLE" AND "WITH ALL FAULTS", WITHOUT ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND, WHETHER EXPRESS, IMPLIED OR STATUTORY. **IMPLIED WARRANTIES OF MERCHANTABILITY**, FITNESS FOR A PARTICULAR PURPOSE, ACCURACY, TITLE, CORRESPONDENCE TO DESCRIPTION AND NON-INFRINGEMENT ARE EXCLUDED. RGRTA DOES NOT WARRANT THAT THE DATA WILL BE AVAILABLE AT ANY PARTICULAR TIME, THAT THE DATA WILL BE SECURE, OR THAT THE DATA WILL BE ACCURATE, FREE FROM BUGS, INACCURACIES OR VIRUSES, OR FREE OF ERROR. THE LICENSEE AND ANY THIRD

PARTY THAT ACCESSES OR USES THE DATA OR USES ANY APPLICATION PRODUCED OR PROVIDED BY THE LICENSEE THAT USES THE DATA DOES SO AT THEIR OWN RISK AND ASSUMES THE RISK THAT THE DATA MAY PROVIDE INCORRECT INFORMATION, AS WELL AS THE RISK THAT ANY DATA DOWNLOADED BY LICENSEE MAY CAUSE LOSS OF DATA OR DAMAGE TO LICENSEE'S COMPUTER SYSTEM OR THAT OF ANY OTHER THIRD PARTY.

LICENSEE AGREES THAT IN NO EVENT WILL RGRTA, ITS SUBSIDIARIES, THEIR DIRECTORS, OFFICERS, EMPLOYEES OR AGENTS BE LIABLE TO LICENSEE OR ANY OTHER PERSON FOR ANY DAMAGES, INCLUDING, WITHOUT LIMITATION, LOSS OF PROFITS, INDIRECT, SPECIAL, CONSEQUENTIAL, EXEMPLARY, PUNITIVE OR INCIDENTAL DAMAGES, HOWEVER CAUSED, WHETHER BASED UPON CONTRACT, OR TORT (INCLUDING NEGLIGENCE AND STRICT LIABILITY), WARRANTY, OR ANY OTHER LEGAL THEORY, ARISING OUT OF OR RELATED TO THE EXISTENCE, FURNISHING, FAILURE TO FURNISH, OR USE OF ANY DATA, AND LICENSEE HEREBY RELEASES RGRTA AND ITS SUBSIDIARIES FROM ANY AND ALL SUCH DAMAGES. RGRTA DOES NOT WAIVE ANY SOVEREIGN IMMUNITY IN CONNECTION WITH THIS AGREEMENT.

5. RGRTA reserves the right at any time and from time to time to alter or no longer provide the Data (or any part thereof) or to provide the Data in a different format, temporarily or permanently, with or without prior notice. Licensee agrees that RGRTA and its subsidiaries will not be liable for any modification, suspension or discontinuance of the Data or link to the Data. RGRTA does not currently charge a fee for the Data, but reserves the right to institute a fee at any time in the future without prior notice.

6. RGRTA retains all title, ownership, rights (including copyrights and other intellectual property rights) and interest in and to the Data. Licensee agrees to comply with all laws, regulations, policies and other legal requirements relating to the promotion, use, distribution, or control of the Data.

7. Licensee agrees to indemnify and hold RGRTA and its subsidiaries harmless from, and reimburse RGRTA and its subsidiaries for, any and all claims, actions, proceedings, penalties, damages, settlements, judgments, costs and expenses, including reasonable attorneys' fees, arising out of or relating to Licensee's use or distribution of the Data or Licensee's performance or breach of this Agreement, regardless of whether such claims arise out of the law of torts or contracts; and to indemnify, hold RGRTA and subsidiaries harmless from and reimburse RGRTA and its subsidiaries for any and all costs and expenses, including reasonable attorney's fees, arising out of efforts to enforce Licensee's obligations under this paragraph.

8. All notices or other communications under this Agreement must be delivered by first class mail to:

The failure of either party to enforce at any time any of the provisions of this Agreement, or the failure to require at any time performance by the other party of any of the provisions of this Agreement, will in no way be construed to be a present or future waiver of such provisions, nor in any way effect the ability of either party to enforce each and every such provision thereafter.

10. This Agreement shall be governed by and construed in accordance with the laws of the State of New York without regard to any conflict of law doctrine. Each party to this Agreement submits to the exclusive jurisdiction of the state and federal courts sitting in Monroe County in the State of New York, and waives any jurisdictional, venue or inconvenient forum objections to such courts. In the event that any of the provisions of this Agreement are held by a court to be unenforceable, such provision shall be limited or eliminated to the minimum extent necessary and this Agreement shall otherwise remain in full force and effect and enforceable.

11. This Agreement constitutes the complete agreement between RGRTA and Licensee with respect to the subject matter hereof and supersedes all prior oral or written understanding, communications, or agreements not specifically incorporated herein. RGRTA reserves the right to modify or revoke this Agreement at any time.
